2. The Account shall be operated by the Managing Director, Gujarat State Divyangjan Finance and Development Corporation, only.
3. Detailed instructions issued by the Finance Department and the Accountant General from time to time regarding **Personal Deposit/Personal Ledger Account (PD/PLA)** shall be strictly followed.
