AND WHEREAS, the Social Justice and Empowerment Department, Government of Gujarat (hereinafter referred to as the Department), is administering Term Loan Scheme (hereinafter referred to as the Scheme) to provide assistance/loan for the social, educational and economic development of the backward classes, which is being implemented through the Gujarat Minorities Finance & Development Corporation Limited, Gandhinagar (hereinafter referred to as "the Implementing Agency");

 - (vii) Kisan Photo passbook; or
 - (viii) Driving License issued by the Licensing Authority under the Motor Vehicles Act, 1988 (59 of 1988); or
 - (ix) Certificate of identity having photo of such person issued by a Gazetted Officer or a Tehsildar on an official letter head; or
 - (x) Any other document as specified by the Department.
 - Provided further that the above documents shall be verified by an officer specifically designated by the Department for that purpose.

AND WHEREAS, the Social Justice and Empowerment Department, Government of Gujarat (hereinafter referred to as the Department), is administering Pre Examination Training to NEET, JEE, GUJCET etc. Scheme (hereinafter referred to as the Scheme) to provide assistance/loan for the social, educational and economic development of the backward classes, which is being implemented through the Director, Developing Caste Welfare (hereinafter referred to as "The Implementing Agency");
