**No. GL/22/2025/SJED/EOD/e-file/17/2025/0902/J Section:-** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to repeal the Assistant Teacher (other than Assistant Teacher for Special or Technical or both subjects), Class-III, in Higher Secondary Section of the Government Ideal Residential Schools for Scheduled Castes, Recruitment Rules, 2016, namely:-

1. These rules may be called the Assistant Teacher (other than Assistant Teacher for Special or Technical or both subjects), Class-III, in Higher Secondary Section of the Government Ideal Residential Schools for Scheduled Castes, Recruitment (Repeal) Rules, 2025.
2. The Assistant Teacher (other than Assistant Teacher for Special or Technical or both subjects), Class-III, in Higher Secondary Section of the Government Ideal Residential Schools for Scheduled Castes, Recruitment Rules, 2016, issued under the Government Notification, Social Justice and Empowerment Department No. GH/SH/2016/3/MKM/102013/765935/J, dated the 21st January, 2016, are hereby repealed:

Provided that such repeal shall not affect anything done or any action taken under the rules so repealed.
