No : GHL/2021/3/MKM/112020/238162/A: In exercise of the power Constitution of conferred by the proviso to article 309 of the Constitution of India and in India supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the conditions of service of persons appointed to the post of Social Welfare Inspector, Class III in the Directorate of Developing Caste Welfare. under the Social Justice and Empowerment Department. Gujarat State in so far as they relate to the passing of departmental examination for promotion to the post of Assistant Social Welfare Officer, Class III, namely.-1. Short title, extent and commencement. These rules may be called Assistant Social Welfare Officer. Class (1)III (Departmental Examination) Rules 2021. They shall come into force from the date of their publication in the (2)Official Gazette. They shall apply to the persons appointed as Social Welfare (3)Inspector, Class III in the Directorate of Developing Caste Welfare, under the Social Justice and Empowerment Department, Gujarat State whether by promotion or otherwise. (4) · Notwithstanding anything contained in sub-rules (3), where any such person has before the appointed date passed the relevant departmental examination or has been exempted under the old rules from passing the relevant examination, shall not be required to pass the departmental examination. 2. Definitions.-In these rules, unless the context otherwise require.-

(a) "Appendix" means an Appendix appended to these rules:

- (b) "appointed date" means the date on which these rules shall come into force;
- (c) "Board" means the Gujarat Subordinate Service Selection Board,
  Gandhinagar or such institute as may be specified by the
  Government:
- (d) "Departmental Examination" means the departmental examination for promotion to the post of Assistant Social Welfare Officer, Class III in the Directorate of Developing Caste Welfare, Gujarat State;
- (e) "Direct recruit" means a person appointed as Social Welfare Inspector, Class III otherwise than by promotion;
- (f) "Government" means the Government of Gujarat;
- (g) "old rules" means "Gujarat Social Welfare Department (Conditions of Service Relating to sub service Department and Higher Departmental Examination) Rules-1976" and "Gujarat Social Justice and Empowerment Department (Conditions of Service Relating to sub service Departmental and Higher Departmental Examination) Rules, 2008";
- (h) "Relevant Departmental Examination" means the Departmental examination prescribed under the old rules ;
- (i) "specified chances" means the number of chances specified in these rules within which a person is required to pass the examination;
- (j) "specified period" means the period specified in these rules within which a person is required to pass the relevant examination.

# 3. Eligibility to appear in the Examination.-

- (a) No person shall be eligible to appear at the departmental examination unless he has completed three years service after his appointment on post of Social Welfare Inspector, Class III.
- (b) No person shall be eligible to appear in the departmental examination unless he has passed the Post-training examination



for existing post or he has been exempted from the Post-training examination by Competent Authority, if any.

(c) To be eligible for promotion to the post of Assistant Social Welfare Officer. Class III a person shall be required to pass the departmental examination within a period of three years and within three chances.

Provided that any person has before the appointed date passed the relevant departmental examination or has been exempted under the old rules from passing the relevant departmental examination, shall not be required to pass the departmental examination.

Provided furthers that a person belonging to Scheduled Castes or Scheduled Tribes may be given one additional chance which shall have to be availed of within a period of one year from the date of the declaration of the result of the examination of his third chance. Provided also that where the period of passing the departmental examination expires before providing the person, the chances available to him under these rules, the said period shall be deemed to have been extended up to the result of the examination.

- (d) The chances for passing the relevant departmental examination shall be deemed to have been provided under these rules and a person who has been provided any chance under the old rules shall be allowed to avail the remaining chances under these rules.
- (e) If a person, fails to pass the departmental examination, referred to in these rules within the specified period and specified chances, he shall, notwithstanding such failure, be eligible to appear in the departmental examination at any time on payment of an examination fees as may be determined by the Government from time to time in this behalf and on passing the such departmental examination, he shall be eligible for promotion:

Provided that the person shall not be entitled to claim seniority over those persons who have passed the departmental examination

earlier than him and also have been promoted before he became eligible for such promotion on passing departmental examination after specified chances;

# 4. Paper and Syllabus.

- The syllabus of the examination shall be as specified in the Appendix 'A' appended to these rules.
- (2) The examination shall consist of five papers having 100 (one hundred) marks each. The examination shall consist of Multiple Choice Questions (MCQ) except Paper V which will be descriptive. Answers in Paper V shall be required to be written in English or Gujarati, as per the instructions given in the question paper.
- (3) The Candidate shall be allowed to answer the entire subjects of papers I to IV with the help of Books, except paper-V which shall be without books.

Explanation. –"With books" means original book of the subjects approved by the Government or Institute which includes bare Acts and / or rules without any commentaries or case laws and includes manuals issued under the Act published as approved by the Government.

# 5. Holding of Examination.

- The Departmental examination shall be held ordinarily twice in a year by the Board.
- (2) The place, date and time for holding the Departmental examination shall be communicated by the Board to the Directorate of Developing Caste Welfare Department under intimation of the Secretary to the Government of Gujarat, Social Justice Empowerment Department, Gujarat State, and the same shall be communicated to the candidates by the Directorate of Developing Caste Welfare.



# 6. Application for appearing in the Departmental Examination.

- (1) A person who desires to appear at the examination shall be required to submit his application for enlisting his name as a candidate for such examination to the board through the Director Developing Caste Welfare, Gujarat State, in the form as prescribed in Appendix 'B' at least sixty days before the date of the commencement of the examination.
- (2) The Director, Developing Caste Welfare shall scrutinize the application and ascertain his eligibility for appearing in the departmental examination in accordance with these rules. The Director, Developing Caste Welfare shall forward the same along with the Certificate of Eligibility as specified in Appendix 'C' under this rules to the Board.
- (3) The Board shall admit the candidate to the examination on thestrength of the certificate issued by the Directorate of DevelopingCaste Welfare.
- (4) If the applicants subsequently decides not to appear at the Examination, he shall give an intimation thereof to the Board through the Directorate of Developing Caste Welfare, at least thirty days before the date of the commencement of the examination.
- (5) In the event of any person failing to appear at the examination after having enlisted his name as a candidate for appearing as such but without intimating as aforesaid, he shall be deemed to have lost one chance to pass the examination:

Provided that the government may condone such failure on the part of the concerned person to give intimation as referred to in sub-rule (4) and the consequence arising there from if it is satisfied that the person has failed to give intimation within time for the reason beyond his control.



- 7. Standard for passing Examination.
  - The standard for passing the examination shall be of fifty percent
    (50%) of the total marks assigned to each paper;
  - (2) An unsuccessful candidate who has secured sixty per cent (60%) or more marks in any one or more papers shall be exempted from appearing in those papers at the subsequent examination;
  - (3) The candidate who secures eighty percent (80%), or more aggregate marks in the examination in the first chance shall be paid cash amount as an incentive as determined by the Government.
- 8. Publication of result.- The result of examination shall be published by the Board in the *official gazette* and shall forward to the Director, Developing Caste Welfare, Gujarat State under the intimation to the Social Justice and Empowerment Department. The Director Developing Castes Welfare, Gujarat State shall intimate the result to the candidates.
- 9. Prohibition to use certain devices in the exam hall.- The candidate shall not be allowed to carry with him any electronic communication devices like cellular phone, calculator, pager, etc. in the examination hall.
- 10. Mark- Sheet and rechecking of Marks.- The candidate, who desires to have his marks of the examination rechecked, may apply to the Board, through the Director Developing Caste Welfare, along with such fees as may be fixed by the Board for each paper within a period of thirty days from the date of declaration of the final result of the examination.
