CONSTITUTION OF INDIA.

No. (GN-48)VVK-122014-789-TH3(FD/RIR/e-file/4/2025/0991/TH-3) :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Joint Commissioner of Commercial Tax, Class-I, Recruitment Rules, 2008, namely:-

- 1. (1) These rules may be called the Joint Commissioner of Commercial Tax, Class-I, Recruitment (Amendment) Rules, 2025.
 - (2) They shall come into force on the date of their publication in the *Official Gazette*.
- 2. In the Joint Commissioner of Commercial Tax, Class-I, Recruitment Rules, 2008 (hereinafter referred as "the said rules") for the words "Joint Commissioner of Commercial Tax," wherever they occur the words, "Joint Commissioner of State Tax" shall be substituted.
- 3. In the said rules, in rule-2, in sub-rule-(a), in clause (i), for the words "Deputy Commissioner of Commercial Tax", the words "Deputy Commissioner of State Tax" shall be substituted.
- 4. In the said rules for the words "The Commissionerate of Commercial Tax", wherever they occur the words "The Commissionerate of State Tax" shall be substituted.
- 5. In the said rules, in rule 2, in sub-rule-(a), for the words, "by promotion on the basis of the principle of selectivity within the zone of consideration irrespective of seniority in accordance with the provisions of the", the words "by promotion of a person who possesses "Very Good" bench mark for being considered fit for promotion within the zone of consideration as laid down in the" shall be substituted.

CONSTITUTION OF INDIA.

No:-(GN-49) FD/OTH/e-file/4/2023/2859/GH(DAT-Estt):- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Director of Insurance, Class-I, in General State Service, under the Directorate of Insurance, Gujarat State namely:-

- 1. (1) These rules may be called the Director of Insurance, Class I, in the General State Service, under the Directorate of Insurance Recruitment Rules, 2025.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Appointment to the post of Director of Insurance, Class-I, in the General State Service, under the Directorate of Insurance, shall be made either:-
 - (1) by promotion of a person who possess 'very good' bench mark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who:-
 - have worked for not less than five years in the cadre of Deputy Director of Insurance, Class-I, in the General State Service, under the Directorate of Insurance;
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination Rules), 2006; and
 - (iii) have passed Associateship Examination with General Insurance Subjects (Non-life) only, from the Insurance Institute of India:

Provided that where the appointing authority is satisfied that the person having the experience specified in clause (i) above is not available for promotion and it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in clause (i) above; or

- (2) by temporary transfer on deputation basis from amongst the persons working in the cadre of Joint Director Class I, in the Gujarat Accounts Service until the suitable candidate is available as provided in sub-rule (1) above from Directorate of Insurance.
- 3. The Candidate appointed by promotion shall be required to undergo such training and to pass such examination as may be prescribed by the Government.

CONSTITUTION OF INDIA.

No. GVN/2025/(09)/EXAM/1816/1567/D-2:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the conditions of service of the persons appointed to the post of Surveyor, class-III in the subordinate services under the Forest and Environment Department in so far as they relate to their

passing of the Departmental Examination to be eligible for promotion to the post of Range Forest Officer (Survey) Class-III in the subordinate service of the Forest and Environment Department, namely:-

1. Short title commencement and application. -

- (1) These rules may be called the Range Forest Officer (Survey) Class-III (Departmental Examination) Rules, 2025.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- (3) They shall apply to the persons who are appointed to the post of Surveyor Class-III in the Subordinate Service, under the Forest and Environment Department Gujarat state by Direct selection or by promotion.

2. **Definition.** - In these rules, unless the context otherwise requires;

- (a) "Appendix" means an appendix appended to these rules;
- (b) "Appointment date" means the date on which these rules shall come into force;
- (c) "Board" means Gujarat Subordinate Service Selection Board, Gandhinagar.
- (d) "examination" means the Departmental Examination prescribed under these rules for promotion to the post of Range Forest Officer (Survey), Class-III in the Subordinate Service of the Forest and Environment Department.
- (e) 'Old Rules' means the rules in force immediately before the appointed date.
- (f) "Specified Chances" means the number of chances specified in these rules within which a person is required to pass the examination.
- (g) "Specified Period" means the period specified in these rules within which a person is required to pass the examination.
- (h) "Surveyor" means who are appointed as Surveyor Class-III in the Subordinate Service, in Forest Department.
- (i) "Range Forest Officer (Survey)" means who are appointed as Range Forest Officer (Survey) Class-III in the Subordinate Service, in Forest Department.
- (j) "Relevant Examination" means departmental examination prescribed under the old rules.
- **3. Requirement to pass the Examination.** The person appointed to the post of Surveyor shall be required to pass the examination to be eligible for promotion to the post of Range Forest Officer (Survey).
- **4.** Eligibility to appear in the Examination. (1) No person shall be eligible to appear in the examination unless he has completed three years' service after his appointment on the post of Surveyor.

(2) No person shall be eligible to appear in the examination unless he has passed the post-training examination for existing post or he has been exempted from the post-training examination by the competent authority, if any.

5. Specified Chances and period for passing the Examination. -

(1) To be eligible for promotion to the post of Range Forest Officer (Survey) Class-III, a person shall be required to pass the Examination within a period of three years and within three chances from the date of his completing three years' continuous service after his appointment as Surveyor, Class-III:

Provided that a person belonging to the Scheduled Caste or Scheduled Tribes may be given one additional chance which shall have to be availed of within a period of one year from the date of declaration of the result of the examination of his third chance;

(2) If a person fails to pass such examination referred to in these rules within the specified period and within specified chances, he shall notwithstanding such failure, be eligible to appear at any time in the examination on payment of an examination fees as may be determined by the Government from time to time and if he passes the said examination, he shall be eligible for promotion:

Provided that, such person shall not be entitled to claim seniority over those persons who have passed the examination earlier than him and also have been promoted to the post of Range Forest Officer (Survey) under the serules before he became eligible for such promotion on passing the examination:

Provided further that a person who has been provided with any chances under the old rules shall be allowed the remaining chances under these rules.

(3) Non-appearance in the examination shall be considered as a chance.

6. Syllabus and Scheme of Examination. -

- (1) The syllabus for the examination shall be as specified in the Appendix 'A'.
- (2) The examination shall consist of five papers each of 100 (one hundred) marks. The examination shall consist of Multiple Choice Questions (MCQ), and practical test.
- (3) The candidate shall be allowed to answer the entire paper 1 to 4 with the help of books.

Explanation: "With books" means original books of the subjects approved by the government or the Institute having bare Acts and/or rules without any commentaries or case laws and includes manual issued under the Act published or approved by the Government of Gujarat.

7. Medium of the examination. - The medium of examination shall be Gujarati or English as per the instruction given in the question paper.

8. Holding of Examination. -

- (1) The Board shall hold the examination at least twice in a year;
- (2) The Board shall communicate the tentative programme of examination to the office of Principal Chief Conservator of Forests, Gujarat State, Gandhinagar at least ninety days before the provisional date decided by the Board.
- (3) A person who desires to appear in the examination shall be required to send his application in the Form as specified in Appendix-'B' to the Board through the office of Principal Chief Conservator of Forests, Gujarat State, Gandhinagar for enlisting his name as a candidate for such examination at least sixty days prior to the date of the examination;
- (4) The Principal Chief Conservator of Forests and Head of Forests Force Gujarat State, Gandhinagar shall scrutinize the application with regard to his eligibility for appearing in the examination and forward the same to the Board with the Certificate of eligibility as specified in Appendix-'C';
- (5) If the applicant subsequently decides not to appear in the examination, he shall give intimation thereof to the Board through the Principal Chief Conservator of Forest and Head of Forest Force, Gujarat State, Gandhinagar at least thirty days before the date of commencement of the examination.
- (6) If any person fails to appear in the examination after having enlisted his names as a candidate without giving intimation referred to in sub-rule (5), he shall be deemed to have lost one chance to pass examination:

Provided that the Principal Chief Conservator of Forest and Head of Forest Force, Gujarat State, Gandhinagar may condone the failure on the part of the person to give intimation referred to in subrule (5) and the consequences arising therefrom, if it is satisfied that the person has failed to give intimation within the time limit for reasons beyond his control;

- (7) The Board shall admit the candidate to the examination on the basis of the Certificate issued by the Principal Chief Conservator of Forest and Head of Forest Force, Gujarat State, Gandhinagar that he is eligible to appear in the examination:
- (8) The place, date and time for holding the examination shall be communicated by the Board and the same shall be communicated to the candidates by the Principal Chief Conservator of Forest and Head of Forest Force, Gujarat State, Gandhinagar.

9. Standard for Passing the examination. -

- (1) The standard for passing the departmental examination shall be fifty percent (50%) of the total marks assigned to each paper;
- (2) An unsuccessful candidate who secures fifty percent (50%) or more marks in any one or more papers shall be exempted from appearing in those papers at the subsequent examinations.
- (3) In case a candidate is not able to obtain the qualifying standard in only one question paper in the examination, such candidate shall be given grace marks up to 5% of the total marks for that question paper and thereafter, if he obtains the marks equal or more than qualifying standard, he shall be declared pass.
- **10. Result of examination.** The Board shall publish the result of the examination on its official website and shall forward the same to the Principal Chief Conservator of Forest and Head of Forest Force, Gujarat State, Gandhinagar who shall intimate the result to the candidates.
- **11. Incentive.** The candidate who has secures eighty percent (80%) or more aggregate marks in the examination in first chance shall be paid such cash amount as an incentive as may be determined by the Government from time to time.
- 12. Prohibition to use certain devices in the examination Hall. The candidate shall not be allowed to carry with him any electronic communication devices like cellular phone, calculator, laptop, etc. in the examination hall.
- **13. Repeal and Saving. -** The old rules made for the promotion to the post of Range Forest Officer (Survey), Class-III and any other rules corresponding thereto in force immediately before the coming into force of these rules are hereby repealed:

Provided that such repeal shall not affect anything done or actions taken under any of the rules, so repealed.

AADHAAR (TARGETED DELIVERY OF FINANCIAL AND OTHER SUBSIDIES, BENEFITS AND SERVICES) ACT, 2016.

GL/11/2025/SJED/SFE/e-file/17/2022/2060:- WHEREAS the use of Aadhaar number to establish identity enables individuals to receive subsidies, benefits and services in a convenient and seamless manner, obviates the need for multiplicity of documents to establish identity, simplifies processes and promotes transparency and efficiency;

AND WHEREAS, the Director, Scheduled Caste Welfare, Government of Gujarat (hereinafter referred to as "the said Agency") under the administrative purview of the Social Justice and Empowerment Department (*hereinafter referred to as "the said Department"*) in the Government of Gujarat (*hereinafter referred to as "the said Government"*)

is administering issuance and verification of the Scheduled Caste Certificate (*hereinafter referred to as "the said Scheme"*);

AND WHEREAS, under the said Scheme, the Caste Certificate is provided for the purpose of scheme related benefits, reservation in local Self-Government elections, reservation in educational institutions as well as reservation in State Government employment (*hereinafter referred to as "the said benefit"*) is given to the person/member belongs to the Scheduled Castes (*hereinafter referred to as "the beneficiaries"*) under the said Scheme and the instructions and guidelines issued in respect thereof;

AND WHEREAS, expenditure for the said Scheme is incurred from the Consolidated Fund of State of Gujarat;

AND WHEREAS, the said Department is desirous that the said Government, for the purpose of establishing identity of a beneficiary as a condition for the receipt of the said benefit, require that such beneficiary undergo authentication, or furnish proof of possession of Aadhaar number or in the case of an individual to whom no Aadhaar number has been assigned, make an application for enrolment;

NOW, THEREFORE, in pursuance of the provisions of section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (*hereinafter referred to as "the said Act"*), the Government of Gujarat hereby notifies the following, namely:-

- 1. (1) An individual desirous of availing of the said benefit under the said Scheme shall be required to undergo authentication, or furnish proof of possession of Aadhaar number.
 - (2) In case such an individual has not been assigned an Aadhaar number, he shall be required to make an application for enrolment:

Provided that if that individual is a child, such application shall be made only with the consent of his parent or legal guardian.

(3) In accordance with the provisions of regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the said Social Justice and Empowerment Department shall ensure enrolment of such beneficiaries who are yet to be enrolled, or update their Aadhaar details through appropriate measures, including coordination with Registrars and setting up enrolment centres at convenient locations or providing enrolment facilities by becoming a Registrar itself:

Provided that till such time an Aadhaar number is assigned to such beneficiary, he may establish his identity to avail of the said benefit. by presenting the following documents to which he is entitled and which are valid at the time of presentation, or, in case the software provided or authorized by the said Social Justice and Empowerment Department for such identification supports electronic obtaining of information evidencing the contents of such documents from the database of the authorities dealing with the preparation or maintenance thereof, by giving his consent for so obtaining, namely:

For a child below 18 years of age to whom an Aadhaar number has not been assigned:

- (a) The acknowledgement of the beneficiary having undergone the process of enrolment, provided by the operator at the enrolment Centre, containing the Enrolment ID (EID): and
- (b) Any one of the following documents to evidence that the beneficiary is a child below 18 years of age, namely:-
 - Certificate of birth given under the Registration of Births and Deaths Act, 1969, as extracted from the entry made in the register of births regarding the birth of the beneficiary;
 - (ii) Indian passport;
 - (iii) Certificate or statement of marks of matriculation or 10th class or higher secondary or 12th class, issued by a recognized board of school education;
 - (iv) In respect of a child in need of care and protection or a child in conflict with law, who is housed by Child Care Institution registered as such with the State Government concerned under the rules made by it under the Juvenile Justice (Care and Protection of Children) Act 2015, certificate specifying his date of birth issued by the person-in-charge, superintendent, child welfare officer or probation officer of such institution; or

- (v) In respect of a foreign national:-
 - (I) if he is an Overseas Citizen of India Cardholder, Overseas Citizen of India Card;

- (4) An officer designated by the said Social Justice and Empowerment Department in this behalf shall check in respect of the documents presented or the information evidencing the contents thereof under clause (3),-
 - (a) the status of the enrolment request by submitting the EID on myAadhaar portal (<u>https://myaadhaar</u>. uidai.gov.in/portal) to confirm that the EID is valid and that the enrolment request does not stand rejected; and
 - (b) the other documents, and for this purpose, may take the assistance of and share the Information presented with any government entity or an authority that deals with the preparation or maintenance of the information contained in such documents.
- 2. In order to enable beneficiaries to avail of the said benefits conveniently, the Ministry shall make all necessary steps to ensure wide publicity through media to make the beneficiary aware of the requirement of Aadhaar Number under the said Scheme.
- 3. Where the authentication of the Aadhaar number of a beneficiary done through any of the biometric-based modes of authentication (namely, facial Image. fingerprint or iris scan based authentication) fails due to any reason, such as poor quality of biometrics information, The following remedial mechanisms shall be adopted, namely: -
 - (a) In case any biometric-based mode of authentication is not successful, any other mode of biometric-based authentication or one-time pin (OTP) based authentication shall. Wherever feasible and admissible, be offered.
 - (b) In cases where biometric -based or OTP-based modes of authentication are not possible, benefits under the said scheme may, after establishing the genuineness of the Aadhaar number by doing offline verification of the digital signature certificate of UIDAI on the Aadhaar Secure Quick Response (QR) Code or the Aaadhaar Paperless Offline e-KYC documents, as the case may be, be given on the basis of any of the following:
 - (i) An Aadhaar Secure Quick Response (QR) Code containing Aadhaar card, Aadhaar letter (i.e., the letter issued to an Aadhaar number holder on generation of his Aadhaar number) or e-Aadhaar (i.e., the password protected electronic copy of Aadhaar letter downloadable from the website of UIDAI or accessible using its mAadhaar app), after its genuineness is established through offline verification by scanning the QR code using the Aadhaar QR Scanner or mAadhaar apps.
 - (ii) Aadhaar Paperless Offline e-KYC document (downloadable from the website of UIDAI or accessible using its mAadhaar app), after its genuineness is established through offline verification of the digital signature certificate of UIDAI on the document through the application developed by the Ministry or Department or scheme implementing agency concerned for this purpose, in accordance with the details given in this regard on the website of UIDAI.
- 4. Notwithstanding anything contained herein above,-
 - (a) benefit under the said scheme shall not be denied to a child-
 - (i) in case of failure to establish his identity by undergoing authentication or to furnish proof of possession of Aadhaar number, or

- (ii) in case of production of an application for enrolment where he has not been assigned an Aadhaar number; and
- (b) benefit under the said scheme shall be given to such a child by verifying his identity and establishing his relationship with his parent or legal guardian in the manner specified in the proviso to clause (3) of paragraph 1; and
- (c) where benefit is given under clause (b), a record shall be maintained in respect of the same, which shall be reviewed and audited periodically by the Social Justice and Empowerment Department.
- 5. In order to ensure that bona fide beneficiaries who are aged 18 years or more are not deprived of the benefit due to them under the said scheme, the Social Justice and Empowerment Department shall follow the exception handling mechanism specified in the Office Memorandum no. D-26011/04/2017-DBT, dated the 19th December, 2017 of the Direct Benefit Transfer Mission, Cabinet Secretariat, Government of India (available on https://dbtbharat.gov.in).
- 6. This notification shall be effective from the date of its publication in the Official Gazette.
