## Chapter - 9

## Procedure to be followed in process of taking decision

- 9.1 For taking decision on various issues, decisions are taken in respect of powers delegated for disposal of cases at various levels under rules / resolutions / circulars, provisions of Govt. of Gujarat in relation to office procedure and various works / schemes prescribed for non sachivalaya offices
- 9.2 As per order of delegation of power / allocation of works, papers are put up at the level of Deputy Director, Accounts Officers / Joint Director / Director and if required, sanction is obtained from Social Justice and Empowerment Department of the Govt. by making proposals.
- 9.3 Public is intimated by letter.
- 9.4 Generally letters are put up by the branch and it is presented to competent authority for decision. At each stage of representation, the concerned officer to whom file is placed expresses his independent opinion or if he agrees with subordinate officer, he grants sanction.
- 9.5 Competent Authority decides finally according to Rules of Business prevalent other standing instructions and rules of delegation of powers.
- 9.6 The matters to be decided in respect of important cases by Public Information Officers are given below separately.
