RESOLUTION

Government of India has formulated Prime Minister's New 15 Point Programme for the Welfare of Minorities and directed all States/Union Territories to take certain steps for effective implementation of the new programme vide its D.O. letter No. 6-1/2006-MC(P) Dated 4/10/2006. An important aim of the new programme is to ensure that the benefits of various government schemes for the underprivileged reach the disadvantaged sections of the minority communities. The underprivileged among the minorities are, of course, included in the target groups of various government schemes.

States/UTs are directed to constitute a State Level Committee for implementation of the Prime Minister's New 15 Point Programme for the Welfare of Minorities headed by the Chief Secretary with members consisting of the Secretaries and Heads of Departments implementing the schemes under the 15 Point Programme, three Members from parliament representing Gujarat State, two members from Gujarat Legislative Assembly and other non government members and representatives from the Panchayati Raj Institutions etc. considered appropriate by the state government/UT administration.

Now, therefore, after careful consideration, the Government of Gujarat is pleased to constitute the following State Level Committee to achieve the aforesaid goals.


