#### CONSTITUTION OF INDIA

No.GH-SH-13-2016- MKM-102014-697888-CHH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the **post of Chief Officer, Class III**, in the subordinate service of the Directorate of Social Defence, Gujarat State, namely:-

1. These rules may be called the Chief Officer, Class III, in the Directorate of Social Defence, Recruitment Rules, 2016.
2. In these rules unless the context otherwise requires, Chief Officer, Class III, means the posts included in annexure I, annexed to these rules,
3. In these rules unless the context otherwise requires Probation Officer, Class III, means the posts included in annexure II, annexed to these rules.
4. Appointment to the post of Chief Officer, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State, shall be made either,-
  - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who,-
    - (i) have worked for not less than five years in the cadre of Probation Officer, Class III, in the subordinate service under the Directorate of Social Defence, Gujarat State; and
    - (ii) have passed the departmental examination as may be prescribed by the Government; and

- (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a persons having an experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

- (b) by direct selection
5. The appointments by direct selection and promotion shall be made in the ratio of 1:2 respectively.
6. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-
- (a) not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

- (b) possess-
- (i) a at least Second Class degree in Social work or Sociology or Psychology obtained from any of the Universities established or incorporated by or under the Central or the State Act in India; or any other educational institutions recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956;
- (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
- iii) adequate knowledge of Gujarati or Hindi or both.
7. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
8. The candidate appointed by direct selection shall require to pass the departmental examination in accordance with the rules as may be prescribed by the Government.
9. The candidate appointed either by direct selection or by promotion shall require to undergo such training and pass such examination as may be prescribed by the Government.
10. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
