In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Teacher (Higher Secondary), Class III at the Ideal Residential School (Science Stream) for Edieduled Castes in the subordinate service of the Directorate of Scheduled Castes Welfare, namely:

- 1. These rules may be called the Assistant Teacher (Higher Secondary), Class III, Recruitment Rules, 2009.
- 2. Appointment to the post of Assistant Teacher (Higher Secondary), Class III shall be made either,-
- (a) by direct selection, or
- (b) by temporary transfer on deputation basis from amongst the persons working on the cadre of Assistant Teacher, Class III in Higher Secondary (Science Stream) section under various Department of the State.

- 3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall;
  - (a) not be more than 31 years of age;
  - (b) possess -
  - (i) a post graduate degree with Second class in relevant subject for the relevant post and a degree in education obtained from any of the Universities established or incorporated by under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government, or
  - (ii) diploma in education obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act,1956; or possess an equivalent qualification recognised by the Government, and have seven years experience of teaching in relevant subject in Standard X and/or XI and/or XII in the school recognised by the Government.

**Explanation:** Relevant subject for the relevant post means i.e. for the post of Teacher in Mathematic subject, the concerned candidate shall be post graduate with Mathematic subject.

- (c) Possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
- (d) possess the adequate knowledge of Gujarati and /or Hindi.

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services classicisation and Recruitment (General) Rules, 1967.

4. The selected candidate shall be on probation for a period of one year.

5. The candidate appointed by direct selection shall, during his probation period be, required to undergo pre-service training and pass the post training examination in accordance with the rules as may be prescribed by the Government in that behalf.

- 6. The candidate appointed by direct selection shall, during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- 7. The selected candidate shall be required to pass the departmental examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government in that behalf.
- 8. A candidate appointed by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government in that behalf
- 9. The selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government in that behalf.

No.GII/SH/2016/3/MKM/102013/765935/J...: In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules, to provide for regulating recruitment to the post of Assistant Teacher (other than Assistant Teacher for Special or Technical or both subjects), Class-III, in Higher Secondary Section of the Government Ideal Residential Schools for Scheduled Castes, in the subordinate service of the Directorate of Scheduled Castes Welfare, namely:-

- 1. These rules may be called the Assistant Teacher (other than Assistant Teacher for Special or Technical or both subjects), Class, III, in Higher Secondary Section of the Government Ideal Residential Schools for Scheduled Castes, Recruitment Rules, 2016.
- 2. Appointment to the post of Assistant Teacher (other than Assistant Teacher for Special or Technical or both subjects), Class, III, in Higher Secondary Section of the Government Ideal Residential Schools for Scheduled Castes, in the subordinate service of the Directorate of Scheduled Castes Welfare, shall be made either,
- (a) by temporary transfer on deputation basis of teacher (other than Assistant Teacher for Special or Technical or both subjects) of the Government Higher Secondary Schools or Secondary Schools under the Education Department; or
- (b) by direct selection.
- 3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,
- (a) not be more than 39 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

Provided Further that nothing contained in clause (b) of sub-rule 8 of the Gujarat Civil Service Classification and Recruitment (Genral) Rule, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned. (b) possess:-

- (i) a master's degree in Arts or Science or Commerce obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; and
- (ii) a bachelor's degree in Education obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;
- (c) have passed the "Teachers Aptitude Test (TAT)" conducted by the Gujarat Secondary and Higher Secondary Education Board, Gandhinagar with at least 50 percent, marks:

Provided that the marks secured by the candidate in the Teachers Aptitude Test shall be valid for five years from the date of the result of the Teachers Aptitude Test.

- (d) Possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
- (e) Possess the adequate knowledge of Gujarati or Hindi or both.
- 4. The selection of candidate shall be made on the basis of a select list which shall be prepared on the basis of marks secured by the candidates in the Teachers Aptitude Test and other educational qualifications prescribed in clauses (i) and (ii) of sub rule (b) of rule 3 for direct selection. The Teachers Aptitude Test shall be given a weightage of 70 percent, and 30 percent, weightage shall be given to the other prescribed educational qualifications as mentioned below:
