CONSTITUTION OF INDIA

No. GHL/2013/6/SSP/152010/786302/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Social Welfare Officer, Class III, in the subordinate service of the Directorate of Developing Caste Welfare, Gujarat state, namely:-

- These rules may be called the Assistant Social Welfare Officer
 Class III in the Directorate of Developing Caste Welfare,
 Recruitment Rules, 2013.
- Appointment to the post of Assistant Social Welfare Officer, Class
 III, in the subordinate service of the Directorate of Developing
 Caste Welfare, Gujarat state, shall be made either,
 - (A) (a) by promotion of a person of proved merit and efficiency from amongst the persons who, -
 - (i) have worked for not less than five years in the cadre of
 Head Clerk, Accountant, Social Welfare Inspector or
 Assistant Ashramshala Officer, Class III, in the
 subordinate service of the Directorate of Developing Caste
 Welfare; and
 - (ii) have passed the prescribed departmental examination; and

(iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i); or

- (b) by promotion on the basis of the special competitive examination of a person of proved merit and efficiency from amongst the persons who, -
- (i) have worked for not less than five years in the cadre of Head Clerk, Accountant, Social Welfare Inspector or Assistant Ashramshala Officer, Class III in the subordinate service of the Directorate of Developing Caste Welfare; and
- (ii) have passed the prescribed departmental examination for promotion; and
- (iii) Possess a bachelor degree obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared as deemed University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized by the Government; and
- (iv) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat

Civil Services Computer Competency Training and Examination Rules, 2006; and

- (v) have passed the Special Competitive Examination in accordance with the rules prescribed by the Government; or
- (a) The appointments by promotion and by direct selection under subrule (A) and (B) of rule 2 shall be made in the ratio of 2:1. respectively.
 - (b) The appointments by promotion from the cadre of Head Clerk, Accountant, Social Welfare Inspector and Assistant Ashram Shala Officer under clause (a) and (b) of sub rule-A of rule 2 shall be made in the ratio of 1:1.
- To be eligible for appointments by direct selection to the post mentioned in rule 2, a candidate shall,
 - (a) not be more than 30 years of age: Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

(b) Possess-

(B) by direct selection.

- (i) a bachelor degree obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared as deemed University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized by the Government; and
- (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (iii) adequate knowledge of Gujarati or Hindi or both.

- 5. The candidate appointed by direct selection shall be on probation for a period of one year.
- The candidate appointed by direct selection shall, during his probation 6. period, require to undergo pre-service training and to pass the post training examination in accordance with the rules prescribed by the Government.
- The candidate appointed by direct selection shall, during his probation 7. period, require to pass the qualifying examination for Computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- The candidate appointed by direct selection shall require to pass the 8. departmental examination as may be prescribed by the Government.
- The candidate appointed by direct selection shall require to pass an 9. examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
- The candidate appointed either by direct selection or by promotion shall have to undergo such training and pass such examination as may be prescribed by the Government.
- 11. The candidate appointed by direct selection shall be required to furnish a surety and security bond in such form, for such amount and for such period as may be prescribed by the Government.
