No. GHL/2016/19 /SSP/152010/78033/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Deputy Director, Developing Caste Welfare, Class I in the General State Service, namely: -

- These rules may be called the Deputy Director, Developing Caste Welfare, Class I Recruitment Rules, 2016.
- 2. Appointment to the post of Deputy Director, Developing Caste Welfare, Class I in the General State Service shall be made either,
- (a) by promotion of a person of proved merit and efficiency from amongst the persons, who:
  - (i) have worked for not less than eight years in the cadre of Social Welfare Officer (DC) or Ashramshala Officer or Nomadic Tribes Welfare Officer in the General State Service, Class II under the Directorate of Developing Caste Welfare, Gujarat State;
  - (ii) have passed the prescribed departmental examination; and
  - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services
     Computer Competency Training and Examination Rules, 2006,

Provided that where the appointing authority is satisfied that a person having an experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two - thirds of the period specified in sub - clause (i) above; or

- (b) by direct selection.
- 3. The appointments by promotion and by direct shall be made in the ratio of 2:1.
- To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,
- (a) not be more than 40 years of age

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned;

- (b) possess
- (1) a second class Post Graduate degree with Social Work or Rural Study or
  Rural Management or Sociology or a second class Post Graduate

  Diploma in Rural Management obtained from any of the Universities

established or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised as such by the Government; and

- (i) have about three years experience on the post not below the rank of Assistant Social Welfare Officer, Class III in the subordinate service of the Directorate of Developing Castes Welfare, Gujarat State; or
- (ii) have about three years experience in Government or local Bodies or Government undertaking Board or Corporation or Limited Company established under the Companies Act, 2013; or in the Institution registered as Non Government Organisation working in the field of social work on the post of Welfare Assistant or Officer which can be considered equivalent to the post not below the rank of Assistant Social Welfare Officer, Class III in the subordinate service of the Directorate of Developing Castes Welfare, Gujarat State; or
- Management or Sociology obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised as such by the Government; and

- (i) have about five years experience on the post not below the rank of Assistant Social Welfare Officer, Class III in the subordinate service of the Directorate of Developing Castes Welfare, Gujarat State, or
- (ii) have about five years experience in Government or Local Bodies or Government undertaking Board or Corporation or Limited Company established under the Companies Act, 2013; or in the Institution registered as Non Government Organisation working in the field of Social work on the post of Welfare Assistant or Officer which can be considered equivalent to the post not below the rank of Assistant Social Welfare Officer, Class III in the subordinate service of the Directorate of Developing Castes Welfare Gujarat State.
- (c) possess the basic Knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and
- (d) possess adequate knowledge of Gujarati or Hindi or both.
- The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidate appointed by direct selection shall, during his probation period require to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officers Pre-service Training and Examination rules, 1970.
- 7. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer

knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

- 8. The candidate appointed by direct selection shall require to pass the departmental examination as may be prescribed by the Government.
- 9 The candidate appointed by the direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
- 10. The candidate appointed either by promotion or by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.
- 11. The candidate appointed by the direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by Government.

    - (i) have worked for not less than eight years in the cadre
      of Social Welfare Officer, Class II, in the General State
      Service under the Directorate of Developing Castes
      Welfare, Gujarat State;
    - (ii) have passed the departmental examination; and

(iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub — clause (i) above: or

- (b) on the basis of the result of competitive examination held for the purpose.
- The appointment on the basis of the result of competitive examination held for the purpose and by promotion shall be made in the ratio of 1:2 respectively.
- To be eligible for appointment on the basis of the result of competitive examination held for the purpose to the posts mentioned in rule 2, the candidate shall,-
  - (a) not be more than 35 years of age;
  - (b) possess, -
    - (i) a bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other

educational institution recognised as such by the Government or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised as such by the Government;

- the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and
- (iii) adequate knowledge of Gujarati or Hindi or both.
- The candidate appointed on the basis of the result of competitive examination held for the purpose shall be on probation for a period of two years.
- 6. The candidate appointed on the basis of the result of competitive examination held for the purpose shall be required to undergo pre-service training and pass the post training examination during his probation period in accordance with the provision of the Gazetted Officer's Pre-service Training and Examination Rules, 1970.
- 7. The candidate appointed on the basis of the result of competitive examination held for the purpose shall, during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- The candidate appointed on the basis of the result of competitive examination held for the purpose shall be required to pass the

departmental examination and an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
