Scheme of Dr.Babasaheb Ambedkar Award to the Individual with significant contribution in social welfare work.

1) Rules / Procedure of the Scheme :

Dr.Babasaheb Ambedkar Award shall be awarded on individual basis to the person in recognition of his contribution for ensuring social justice and human rights to the Schedule Caste and backward class people and upliftment and development of Scheduled Caste and Backward Class people in respect of educational, economic and social front by creating awareness and inculcating high virtues and culture in their lives and by taking them out of customary traditions and practices.

- 2) Conditions for the Award:-
 - (1) Cash amount of Rs.1,00,000/- and a Letter of Citation for this Award. The amount of award shall be through cheque.
 - (2) This Award shall not be granted posthumous. However, in case if a person dies after his name is recommended/proposed for the Award, he can be considered for posthumous award. In case such an occasion arises for Award posthumously, husband/wife of such person may accept the Award and in case spouse of such Award winner is not alive, his/her legal heirs can accept the Award.

- (3) This Award shall be given to any person of the society without taking into consideration his religion or caste, however, person belonging to Scheduled Caste shall be given priority.
- (4) This Award is to be awarded every year and for this purpose, the year means Financial Year.
- (5) For the purpose of selection of Award, contribution of a person during last 10 years for upliftment of Scheduled Caste and weaker section people will be considered. However, if any such person who has significant contribution at his credit even beyond this period for upliftment of Scheduled Caste and weaker section people will also be considered.
- 3) Procedure for recommendation for the Award:-
 - (1) Following persons/organizations can recommend for the Award—
 - (a) Individual/institutions engaged in the field of Social Welfare and Social Service.
 - (b) Members of Parliament, Members of Legislative Assembly, Hon'ble Judges of High Court.
 - (c) Individuals, organizations or associations having received or won awards at the State, National or International levels.
 - (d) Vice Chancellor of University,
 - (e) Any individual or organization as may be selected by the Award Selection Committee, for recommending name of such individual.

- (2) The individual who recommends his own name for the Award, shall not be considered. Similarly, individual recommendations for Award shall also not be taking into consideration.
- (3) Only one name can be recommended by abovementioned individuals or organizations.
