RESOLUTION

It is resolved to apply the norm of 27% reservation, including open merit" - a provision mentioned in last portion in para-III of the said resolution of this deptt. dated 23-2-1994, mentioned at the said reference no.8 made on order dated 23/2/94 regarding increase in prevalent reservation quota for Socially and economically Backward Classes, for the appointment by direct recruitment in state Govt. services and admission in educational institutes, it is hereby resolved to substitute the same with following provision:

"It is hereby resolved to apply 27% reservation norm alongwith benefit of provision made in Govt. Resolution, General Administration Deptt. No.PVC/1290/2222/G.4 dated 20-5-93, not to consider eligible candidates against reserved seats".

2. As per partial amendment made in para-3 of the above mentioned resolution of this deptt. dated 23-2-94 candidates belonging to Socially ad Educationally Backward Classes, falling under merit list of appointment of recruitment shall not be considered against the reserved seats merit for those classes and but against non-reserved seats. Now 27% reservation prescribed or those classes shall be applied over and above the candidates belonging to those classes being selected on merit.
