RESOLUTION :

The Government of Gujarat has set up a "Gujarat Samast Thakor Vikas Board", an Advisory Board, to look after and to promote economical and developmental activities for the benefit and welfare of "THAKOR & KOLI" communities, including certain backward sections of such communities, under executive orders shown in the preamble. The communities consist of major part amongst Socially & Educationally Backward Class of the State. The matter of emphasizing efforts to help in furthering the Govt. policies and programme for the development of such communicates was under consideration since long.

2. Government, after careful consideration, has now decided to nominate The Gujarat Backward Class Development Corporation, Block No.11, 2nd floor, Dr. Jivraj Mehta Bhavan, Gandhinagar, as Channelising Agency, in lieu of the Thakor Vikas Board, for procurement and sending proposals to the National Backward Class Corporation, New Delhi, for getting approval of schemes, withdrawal of funds etc, from the National Backward Class Corporation, New Delhi. The approved schemes will, in turn, be implemented and monitored by Gujarat Samast Thakor Vikas Board, in consultation with Gujarat Backward Class Development Corporation.

3. The Secretary , Gujarat Samast Thakor Samaj Vikas Board, shall initiate necessary action & workout the plan proposal to be submitted to National Corporation through Gujarat Backward Class Development Corporation . The National Corporation may consider to release funds accordingly.

4. The Managing Director, Gujarat Backward Class Development Corporation, Gandhinagar shall take necessary action as a Channelling Agency in lieu of the Gujarat Samast Thakor Vikas Board. The Secretary of the Thakor Vikas Board and the Director (Dev. Castes) shall assist the channelling agency.

5. These orders are issued in consultation with Finance Department.
