The State Government has under this partment Resolution dated 23/2/'94 as quoted at Sr. No. (1) above, issued orders regarding the increase in the existing percentage of reservation for Socially and Educationally Backward Classes for direct recruitment to the posts and services under the Government and for admission in Ed-ucational Institutions. Apart from the Government jebs, the quota of reservation for SEBC, as per the Government Resolution, General Administration Department, dated 29/5/'78 as quoted above, is also being implemented for the recruitment to the posts and orders in the below mentioned institutions are as under:-

- i) 5 percent reservation for direct recruitment to the posts equivalent to Class- I and Class- II posts and 10 percent for the posts equivalent to Class- III and Class- IV Posts under the statutory Boards, Public enterprises, Public Undertakings such as Boards, Corporations, etc., of the State Government and under the Government aided institutions such as schools, High Schools, Colleges, Universities, Municipalities, Panchayats, etc.
- ii) 10 percent reservation for the recruitment of teachers in primary schools under the District aducation Committees and Town aducation Committees.

The Government is hereby pleased to revise and raise to 27 percent, the existing quota of reservation for SEBC in the recruitment to the posts under all the above mentioned institutions and to implement the same on the lines of the State Government.

2. All the concerned departments are requested to immediately issue necessary detailed orders confirming the above policy decision extending the benefits of reservation to all SEBC/Castes.
