In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Social Welfare Officer Class III, under the Directorate of Developing Castes Welfare, namely;

- These rules may be called the Assistant Social Welfare Officer (Class-III) in the Directorate of Developing Castes (Recruitment Rules) 2001.
- 2. Appointment to the post of Assistant Social Welfare Officer, Class-III in the Directorate of Developing Castes Welfare and its subordinate offices shall be made by promotion of person of proved merit and efficiency from amongst the persons who has worked for not less than five years in the cadre of Head Clerk, Accountant, Social Welfare Inspector and Assistant Ashram Shala Officer in Directorate of Developing Castes or under the Directorate of Social Welfare before their allocation to Directorate of Developing Caste and has passed the prescribed departmental examination for promotion as prescribed by the Government.

Provided that where the appointing authority is satisfied that a person having the experience specified above is not available for promotion and it is necessary in the public interest to fill up the post by promotion of a person having experience for a lesser period, it may, for reasons to be recorded in writing, promote such person who possess experience for a period of not less than two third of the period specified above.
