Rules for grant of Scholarships and examination fee to the students belonging to Socially and Educationally Backward Classes and Economically Backward Classes :-

1. The benefit of this scheme will be available to only those classes who have been declared socially and Educationally Backward Classes and Economically Backward Classes as per Government Resolution, Labour, Social Welfare and Tribal Development Department No. BJR/1078/13734/H, dated the 1st April, 1978.

2. The Scholarships will be awarded as follows for standards V to XI and for professional training. The limit of income and percentage of marks will be as under :-

Income limit :

The income of the parent or guardians of the students belonging to the socially and Educationally Backward Classes and Economically Backward Classes from all sources not to exceed Rs. 4800/- (Rupees four thousand eight hundred only).

<u>Percentage</u>	<u>Amount of Scholarships</u>
1) For standards V to VII 50% marks at the annual examination in previous standards.	Rs. 30/- per annum
2) For standards V to VII in private Schools 60% marks at the annual examinations in previous standards.	Rs. 60/- per annum in Std. V Rs. 75/- per annum in Std. VI Rs. 90/- per annum in Std. VII
3) For standard VIII to XI 50% marks at the annual examinations in previous standards.	Rs. 75/- per annum
4) For Technical Courses 45% marks at qualifying examination.	Rs. 115/- per annum .
5) For Professional training 45% marks at the qualifying examination only for recognised institutions.	Rs. 40/- per month for full time course.

Note (1) The annual scholarships will be paid in one instalment in the first term and the monthly scholarships will be paid in two instalments. One instalment in first term and second instalment in Second term.

2. The students staying in Hostels and studying will be eligible to receive scholarship at the rate of 50%.

3. Examination fee will be payable to those who have secured at least 50% marks in the annual examination of the previous year held at the end of Std. X known as S.S.J. Examination and whose parent or guardians income from all sources is Rs. 4800/- (Rupees four thousand eight hundred only) or less.

4. In the case of Nomadic Tribes and Denotified Tribes, the existing percentage of marks and the existing means test of Rs. 7200/- per annum fixed by Government for eligibility to Scholarships shall continue to remain in force.
5. The benefit of this scheme shall be available to only those students who are studying and staying in Government or Government recognised schools or institutions.
6. The students will have to attend the school regularly. The study shall be satisfactory and behaviour should also be good.
7. The students intending to avail benefit of this scheme shall submit the application to the Head Master /Principal of the School/institution, concerned before 15th July, every year.
8. The Head Masters of the schools or institutions shall send the information in respect of the students belonging to S. E. B. J. and E. B. J. intending to avail benefit of the scheme, in separate prescribed forms before 31st July to the District Social Welfare Officer (State).
9. (1) In order to avail of the above educational benefits if the student or his/her parent or guardians has made false declaration of income or has produced false certificate of income and/or on enquiry if this found to be true double the amount received by him/her will be recovered from him/her. This amount will be recoverable as arrears of land revenue.  
 (2) If the age of the student is more than 18 years and if false declaration about income and/or about caste/class/groups comes to notice, such student will be debarred from the school.  
 (3) The student found to have made false declaration about caste /class/group will not be admitted to any of the schools or educational institutions for a period of three years.  
 (4) Failure to pass the examination will not entitle the student to the scholarship for the same standard.
10. The following information will have to be produced for getting the educational concessions :-
  - (1) Prescribed certificate for S. E. B. J. or E. B. J. Form No. 1 or Form No. 2.
  - (2) Prescribed Form No. 3 or Form No. 4 for getting the Scholarship /examination fee (to be filled by the parent /guardian of the student).
  - (3) Prescribed letter of Affirmation of Income-Form No. 5
  - (4) Information in the prescribed form about the students intending to avail benefit of this scheme. Form No. 6 or Form No. 7 and Form No. 8 or Form No. 9 (to be filled in by the training institutions/educational institutions).
11. Whenever any change in the Scholarship by way of increase are made in the amount of Scholarships payable to Scheduled Castes and Scheduled Tribes, corresponding charges shall be made in the case of students of S. E. B. J. and E. B. J.
12. This scheme shall be implemented by the office of the District Social Welfare Officer (State).
