Sir,

I am directed to invite attention to this Ministry's
O.M. No.36012/22/93-Estt.(SCP) dated 22.10.1993, a copy of which
was enclosed with this Department's Letter No.36012/22/93-Estt.(SCP)
dated 15.11.1993 prescribing the form of certificate to be produced
by other Backward Classes for appointment to posts under the
Government of India.

2. In foot-note (b) below the form of certificate, it has been
stated that where the certificates are issued by Gazetted Officers
of the Union Government or State Governments, they should be in the
same form but countersigned by the District Magistrate or
Deputy Commissioner (certificates issued by Gazetted Officers and
attested by District Magistrate/Deputy Commissioner are not
sufficient). This issue has been re-examined and it has been
decided to delete the existing foot-note (b) below the
form of Certificate, since, in the first place, "Gazetted
Officers" of the Union and state Governments have not been
authorized to issue Caste Certificates.

3. The revised format of the certificate, indicating the
revised foot-note(b), that may be given by the concerned district
authorities would be as in Annexure.

4. The revised form of certificate will be operative from
1st February, 1997.

5. It is requested that wide publicity may be given to this order
and the certificate issuing authorities should be appropriately
briefed in order to ensure prompt and correct certification.

6. A copy of the orders issued by your Government in this regard
may also be endorsed to this department for information.

- (a) The term 'ordinarily' used here will have the same meaning as in Section 20 of the Representation of the People Act, 1950.
 - (b) The authorities competent to issue Caste Certificates are indicated below:-
 - (i) District Magistrate/Additional Magistrate/Collector/Deputy Commissioner/Deputy Collector/1st Class Stipendary Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner (not below the rank of 1st Class Stipendary Magistrate).
 - (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
 - (iii) Revenue Officer not below the rank of Tehsildar,
and
 - (iv) Sub-Divisional Officer of the area where the candidate and/or his family resides.
