R E S O L U T I O N

WHEREAS the Supreme Court of India in Writ Petition  
(Civil) Nos. 930 of 1990 with others in the case of Indra  
Sawhney etc. etc. Petitioners v/s Union of India and  
Others, etc. etc. Respondents, has directed each of the  
State Governments to constitute a permanent body for  
entertaining, examining and recommending upon request  
for inclusion and complaints of over-inclusion and under-  
inclusion in the list of other backward classes of citizens.

AND, WHEREAS, the Government of Gujarat have decided  
to constitute such permanent body in compliance with the  
direction of the Supreme Court :

NOW, THEREFORE, the Government of Gujarat hereby  
appoints Mr. Justice P.R. Gokulakrishnan, the retired  
Chief Justice of the High Court of Gujarat as the Commission.

The Commission will entertain, examine and recommend  
upon requests for inclusion and complaints of over-inclusion



and under-inclusion in the lists of other backward classes of citizens in the State of Gujarat and do such other things ancillary thereto.

The Commission is empowered to obtain such information as it may consider necessary or relevant for its purpose in such form and such manner as it may think appropriate from any authority of the State Government, organisation or individual or individuals as may in the opinion of the Commission, be of assistance to it.

The Commission of Mr. Justice P.R. Gokulakrishnan shall be entitled to the emoluments, allowances, perks, facilities and other benefits as are available to and enjoyed by the Chief Justice of the High Court of Gujarat at Ahmedabad. The Commission will hold the status equivalent to that of the Chief Justice of the High Court of Gujarat.

✓ The duration of the Commission will be five years from the date the Commission takes over the charge.

The Headquarter of the Commission shall be at Gandhinagar.

The expenses will be debited in the following  
Budget Head :

- "2225 - Welfare of SC, ST & Other Backward Classes  
03 - Welfare of Backward Classes  
190 - Financial Assistance to Public Sectors  
(1) - BCK-40 Economic Development Corporation".
