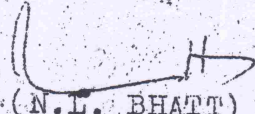
RESOLUTION

The Government of Gujarat has appointed Mr. Justice P.R. Gokulakrishnan, Retd. Chief Justice of the High Court of Gujarat as the Commission for Other Backward Classes. The duration of the Commission has been decided for five years from the date of taking over the charge i.e. 18.3.98.

The Commission has now requested the Government to modify his term of office by limiting it upto 15th August, 1996. The Government is pleased to accept this request of the Commission and hereby modifies his term of office upto 15th August, 1996.

On relinquishment of his charge after 15.8.1996 Hon'ble Justice Mr. P.R. Gokulakrishnan shall be entitled to the facility of transporting households and for journey for himself and his family, from Gandhinagar to Madras as available to the retired Chief Justice of the High Court of Gujarat.
