Resolution:

1. Government of Gujarat, Social Justice & Empowerment Department had given a Government Guarantee on behalf of Gujarat Thakor and Koli Vikas Nigam vide its Resolution No. SSP/1404/1037/A, dated 11/03/2005 as referred to at Sr. No. (1) above for the Term Loan of Rs.2.00 Crore (Rupees Two Crore only) from National Backward Classes Finance and Development Corporation(NBCFDC), New Delhi.
2. Government of Gujarat, Social Justice & Empowerment Department had given a Government Guarantee on behalf of Gujarat Thakor and Koli Vikas Nigam vide its Resolution No. SSP/1404/1037/A, dated 28/03/2008 as referred to at Sr. No. (2) above for the Term Loan of Rs.10.00 Crore (Rupees Ten Crore only) from National Backward Classes Finance and Development Corporation(NBCFDC), New Delhi.
3. So far the Government of Gujarat, Social Justice & Empowerment Department has vacated Government Guarantee(s) of amount of Rs.3.50 Crore (Rupees Three Crore Fifty Lakh only) as per the details given below:

(i) Guarantee for an amount of Rs.3.50 Crore (Rupees Three Crore Fifty Lakh only) was vacated vide Government of Gujarat, Social Justice & Empowerment Department Resolution No. SSP/1404/217056/A.1, dated 15/09/2015 as referred to at Sr. No. (3) above.

4. With the guarantee amount of Rs. 3.50 Crore (Rupees Three Crore Fifty Lakh only) being vacated, the outstanding Guarantee amount is Rs.8.50 Crore (Rupees Eight Crore Fifty Lakh only).

5. Now, Gujarat Thakor and Koli Development Corporation vide its Letter No. GTKVN/Guarantee/19-20/14540, dated 18/09/2019 has requested the Government to vacate the Guarantee of the said amount. Gujarat Thakor and Koli Vikas Nigam is exempted from the payment of Guarantee Fee.

6. The Government of Gujarat is, hereby pleased to vacate a guarantee of Rs.8.50 Crore (Rupees Eight Crore Fifty Lakh only) out of the above mentioned guarantee of Rs.12.00 Crore (Rupees Twelve Crore only) with immediate effect.
