RESOLUTION : - Sanction is accorded to the creation of the following additional temporary posts on the establishment of the Director of Social Welfare, Gujarat State, Ahmedabad with headquarters at Ahmedabad for a period upto 28-2-1979 in the first instance, for the work of implementation of the recommendations of the report of the Socially and Educationally Backward Class Commission and grant of certain benefits to the Economically Backward Classes : -

Sanction is also accorded to the creation of the following additional temporary posts at the District level for a period upto 28-2-1979 in the first instance, for the work relating to the implementation of recommendations of the report of the Socially and Educationally Backward Class Commission and grant of certain benefits to the Economically Backward Classes and for the purchase of 21 type-writer machines - one each for the 17 District offices and for the four offices in the Municipal areas.

The District-wise break up of the above mentioned posts is shown in the accompanying statement. These Officers will work directly under the administrative control of the Director of Social Welfare, Gujarat State.

3. The incumbents of the above posts should be held eligible to receive Dearness Allowance and other allowances as admissible under the normal rules.

4. The expenditure on this account should be debited to the budget head, "236- Social Security and Welfare- B- Other Social Security and Welfare Programme-(a) - Direction and Administration - SCW - Strengthening of Directorate for implementation of the recommendations of the report of the Commission on Socially and Educationally Backward Classes" and should be met from the provision made thereunder during the current financial year.

5. The expenditure on account of the purchase of 21 type-writer machines should be debited to the budget head, "256- Stationery and Printing" and for the purpose of proforma account, the same should be debited to the budget head as mentioned in para-4.
