RESOLUTION

The Government of Gujarat have already nominated Gujarat Backward Class Development Corporation, Gujarat Minorities Development & Finance Corporation and Gujarat Gopalak Development Corporation to be Channelising agencies to the National Corporations in Govt. of India for drawal of funds for the Backward classes of the State. Thereafter, the Gujarat Thakor and Koli Vikas Board (the then advisory board, established under the executive orders) has also been given the status of Corporation, under Govt. Resolution, Social Justice and Empowerment Department No. SSP/142002/971/A dated the 13th Sept. 2002 converting into a Government Company, as incorporated under the Companies Act, 1956 (No.1 of 1956) as "Gujarat Thakor and Koli Development Corporation Limited". Now, in supersession of the GR, SJ & ED No. SSP/142001/892/A dtd. the 11th June, 2002 and in accordance with the objects of this new Company as to promote development activities and to implement various welfare schemes, for the benefit of Thakor and Koli communities the State Govt. is further pleased to nominate the Gujarat Thakor and Koli Development Corporation Limited as a State Channelising Agency to obtain loans from NBCFDC, New Delhi, in addition to the existing other SCAs.

2. The Managing Director, Gujarat Thakor and Koli Development Corporation shall initiate further necessary action and shall workout the plan proposals to be submitted to NBCFDC, New Delhi and the National Commission may in turn, consider to release funds accordingly.
