RESOLUTION

The Government of Gujarat hereby appoints Ms. Sugnaben Kamalashankar Bhatt, former Judge of the High Court of Gujarat as the Commission on the vacant post of the Commission for Socially and Educationally Backward Classes constituted vide Government Resolution No. SSP/1193/KH-102/A, dated 18/3/93 of this department.

2. The Commission, Justice Ms. Sugnaben Bhatt shall be entitled to the emoluments, allowances, perks, facilities and other benefits as are available to and enjoyed by the High Court Judge of the High Court of Gujarat at Ahmedabad. The Commission will hold the status equivalent to that of the High Court Judge of the High Court of Gujarat.
3. The duration of the Commission will be Eight years from the date the Commission takes over the charge.
4. The conditions regarding pay and allowances etc. shall be issued in due course.
