RESOLUTION :

Government of India through Ministry of Social Justice & Empowerment is implementing various Schemes/Programmes through non-governmental organizations and release grant in aid to them based upon the inspection reports/recommendations from the states/UTs.

2. The State Government has accordingly constituted a multi-disciplinary "Grant-in-Aid Committee for supporting the Voluntary Organizations" working for disabled, old persons etc. in the field of Social Defence vide this department G.R.No.APG/102007/DS/CHH.1 Dt.the 9th April, 2008, referred in the preamble(4). As per the constitution of the committee two representatives from the reputed NGOs from the field of Social Defence were nominated. As per the instruction from the government of India vide their letter referred in the preamble (5) were required to be nominated one more representative(Total-3) in the grant-in-aid committee from the reputed NGOs in the field of Social Defence as a members.


3. As per above instruction one expert representatives from the reputed NGOs is hereby nominate. Accordingly now the committee as constituted earlier would consists of the following members:-

5. The above Committee will have to look the following directions, while considering the proposals.

- I. The Committee would examine grounds functioning and suitability of the NGOs for continuation of grants through its field officers. Various schematic guidelines and norms as well as the standardized formats for inspection for field functionaries would continue to remain valid as before. Their proposals would be submitted with all supportivedocuments as at present. However all the proposals should be submitted in one lot and indicating the inter-sc-priority. In case of non indication of such priority this would be taken as per the seriatim number of the recommendation. The recommendation for arrears grants of ongoing projects shall not be considered unless there is a specific recommendation of the State Government for release of grants in aid for the relevant financial year.
- II. While forwarding new cases, the State should ensure that proposals from service deficient areas are arrodod priority, as the Screening Committee of the Ministry for screening of the new cases would take this into consideration along with the other prescribed guidelines.
