No. GH/SH/6/2010/MKM/102007/1080/J:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Joint Director of Scheduled Caste Welfare Class I, in the Gujarat Social Welfare Service, namely:-

- These rules may be called the Joint Director of Scheduled Caste Welfare, Class I, Recruitment Rules 2010.
- 2. Appointment to the post of Joint Director of Schedule Caste Welfare, Class I, in the Gujarat Social Welfar Service shall be made by promotion of a person with possess "Very Good bench mark", for being considere fit for promotion as laid down in the Gujarat Che Services Classification and Recruitment (General)Rule 1967, from amongst the persons who
 - have worked for not less than five years
 the cadre of Deputy Director/Distr
 Backward Class Welfare Officer or Vigilar

Officer Class I, in the Gujarat Social Welfare Service and -

(ii) have passed the qualifying examination for Computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where an appointing authority is satisfied that a person having the experience specified above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period, it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified above.

3. The candidate appointed by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Government in that behalf.
