No.:GHL-18 -SSP-1598-850-A:-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the posts of Deputy Director, Class-I, in the Directorate of Developing Castes Welfare, Gujarat State, namely:-

- 1. These rules may be called the Deputy Director (Developing Castes Welfare) Class-I Recruitment Rules 2001.**
- 2. Appointment to the post of Deputy Director shall be made by promotion of person of proved merit and efficiency from amongst the persons who have worked for not less than eight years either in the cadre of Social Welfare Officer or Ashram Shala Officer Class-II in the Directorate of Developing Castes Welfare, Gujarat State:**


Provided that where the appointing authority is satisfied that a person having the experience specified above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion of a person having experience of a lesser period, it may, for reasons to be recorded in writing,


