CONSTITUTION OF INDIA.

No. GHM/2015/2 /SSP/152010/884664/A :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Lady Tailoring Instructor, Class III in the subordinate service of the Directorate of Developing Caste Welfare, Gujarat state, namely:-

- 1. These rules may be called the Lady Tailoring Instructor, Class III, Recruitment Rules, 2015.
- 2. Appointment to the post of Lady Tailoring Instructor, Class III, in the subordinate service of the Directorate of Developing Caste Welfare, Gujarat state, shall be made by direct selection.
- To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,
  - (a) not be more than 29 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment(General) Rules, 1967.

- (b) possess –
- (i) A certificate of a one year Dress Making Course (NCVT pattern) or a one year computer added Dress making and Dress Designing Course (GCVT pattern) of Government Industrial Training Institute or Industrial Training Institute recognised by the Government.

- (ii) basic knowledge of computer application as prescribed in the Gujarat Civil Services

  Classification and Recruitment (General) Rules, 1967; and
- (iii) adequate knowledge of Gujarati or Hindi or both.
- 4. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
- The selected candidate shall have to undergo such training and pass such examination as may be prescribed by the Government.
- 6. The selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
