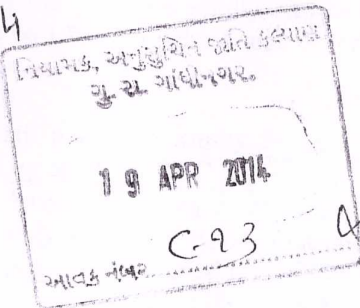

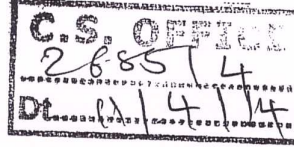

Dear Dr Sinha,

As you are aware, this Ministry is implementing six schemes (listed in the Annexure), under which grants-in-aid are released to NGOs, Voluntary Organisations (VOs) and other eligible organisations like Panchayati Raj Institutions, etc. The eligible organisations have so far been submitting their applications on paper to the District level officers, who in turn conduct mandatory inspection and forward the applications to the Directorate in the State Headquarters for further processing. The State Headquarters in turn, after screening of such applications by the State level Screening Committee, forward them to the Ministry with their recommendations for our consideration. This process has been taking considerable time. As a result, delays have been occurring at various stages, resulting in delays in the release of grants-in-aid to the concerned organisations.

2. In order to streamline the entire process and to make it more efficient & transparent, on our initiative an application has been developed by the National Informatics Centre (NIC) for online filing of the applications by the NGOs, Voluntary Organisations etc. This application will enable the eligible organisations to file their applications online along with required documents. It will also enable processing of applications at the District, State and Ministry levels and eventual release of the requisite grants-in-aid. The application has been put in the public domain today, which may be seen at <http://ngograntsje.gov.in>.

3. I am writing this to request you to direct the Departments concerned with the schemes indicated in the enclosed list, to cause publicity about this application and inform all organisations who are in receipt of grants-in-aid from the Ministry, so that from this year onward, they may submit their applications online through the abovementioned website. First and foremost, they will have to register themselves. The District Informatics Centres have also been advised to provide handholding support that the NGOs/VOs may require in filing their applications online. It may also be kindly emphasised that from current year (2014-15), no paper applications will be entertained and all eligible organisations can file application online only.

4. The concerned Departments may also kindly be directed to have the concerned officers at the State level trained by the State NIC and at the District level by the District Informatics Centres. They will have to get acquainted with the back office processing software at <http://ngograntsje.gov.in/bo-login>. Here too, first and foremost, all official users will have to get themselves registered. A user manual is also available on the website.
