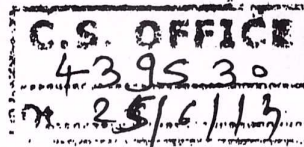

Kindly refer to this Ministry's communication of even number dated 02.4.14 and 02.05.14 regarding ushering in the system of online submission and processing of applications of NGOs/VOs for grants-in-aid w.e.f. current financial year under the following six schemes being implemented by this Ministry:-

- Exptd 25.6.14*
CS
- Integrated Programme for Older Persons (IPoP);
 - Scheme for Prevention of Alcoholism & Substance (Drugs) Abuse;
 - Grants-in-Aid to Voluntary Organisations working for Scheduled Castes;
 - Grants-in-Aid to Voluntary Organisations working for Other Backward Classes;
 - Deendayal Disabled Rehabilitation Scheme (DDRS) to promote Voluntary Action for Persons with Disabilities; and
 - Scheme of Assistance to Disabled Persons for purchase / fitting of aids / appliances (ADIP) Scheme.

2. I may reiterate that the system has been introduced to streamline the entire process and to make it more efficient & transparent, so that hassle-free grants-in-aid is released without undue delay. However, online processing of applications requires officials at the district level, directorate level and the secretarial level to register on the site viz. <http://ngograntsje.gov.in> and create a user-ID for them. The online processing of applications cannot be undertaken until and unless these officials have registered themselves on this site. It is very disappointing that despite repeated requests from this Ministry, a vast number of officers are yet to register on the site.

3. I, therefore, request you earnestly to direct all the State Government officials concerned to register themselves at once on the website. The officers may also be directed to ensure completion of the processing of applications within 30 days at the district level, within 15 days at the Directorate level and within 30 days at the Secretariat level to have grants-in-aid sanctioned on time to the eligible beneficiaries.
