CONSTITUTION OF INDIA.

No. GL/05/2023/SJED/MSM/e-file/17/2023/0203/CHH Section: In Exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Mobility Instructor, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State, namely:-

- 1. (1). These rules may be called the Mobility Instructor, Class III, Recruitment Rules, 2023.
 - (2). They shall come into force from the date of their publication in the Official Gazette.
- **2.** Appointment to the post of Mobility Instructor, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State, shall be made by direct selection.
- 3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-
 - (a) not be more than 37 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess,-
 - (i) a bachelor's degree from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational Institution recognised as such or declared to be a deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government;

- (ii) Degree/Diploma In Orientation and Mobility from an institution recognized by Rehabilitation Council of India, New Delhi or Degree/Diploma course in special education (visually impaired) recognised by Rehabilitation Council of India, New Delhi;
- (iii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (iv) adequate knowledge of Gujarati or Hindi or both.
- **4.** The provisions of rules 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of the candidate appointed by direct selection.
- **5.** The candidate appointed by direct selection shall be required to undergo such training and to pass such examination as may be prescribed by the Government.
- **6.** The Candidate appointed by direct selection shall be required to furnish a security and surety bond in such from, for such amount and for such period as may be prescribed by the Government.
