**ORDER**

WHEREAS the organization Manav Vikas Sanstha (MVS), Beed, Maharashtra is a grantee organization under Deendayal Divyangjan Rehabilitation Scheme (DDRS) of the Department and has been receiving grant-in-aid under DDRS for many years for its following three projects under DDRS Scheme :-

- i. Special School for Orthopaedically Handicapped (OH), Sirsala. Beed
- ii. Special School for Orthopaedically Handicapped (OH), Pathri, Parbhani
- iii. Special School for Intellectual Disability (ID), Kalika Nagar. Beed

2. AND WHEREAS in order to ascertain the satisfactory functioning of the organization/project, the inspection of project at S.No (i) at Para 1 i.e. Special School for Orthopaedically Handicapped (OH), at Sirsala, Telgaon Road, Tq Parli, District Beed, Maharashtra - 431128 being run by the organization MVS, was inspected by this Department. During the inspection conducted on dated 15.12.2023 the Inspection Team (from AYJNISHD, Mumbai) could not find the project at Sirsala. During the inspection, when contacted by the inspecting officials over the phone to the President of the said organization, it was informed that their school was closed from last one year.

3. AND WHEREAS a show cause dated 08.02.2024 was issued to the organization to furnish necessary clarification in the matter. The organization furnished its clarification vide its letter dated 13.02.2024 stating that "no committee came to the said project and also nobody contacted with him on phone on 15.12.2023, the inspection of the said project has already been conducted by concerned authority on 10.01.2024 by Social Officer and 37 beneficiaries were present as per inspection report.

4. AND WHEREAS it was observed that the Inspection report and subsequent clarification submitted by the organization were contradictory. Therefore, the inspection of the organization was again conducted by another agency of this Department i.e. CRC, Nagpur. CRC Nagpur vide its letter dated 10.04.2024 informed that the institute building could not be found. When contacted, Mr. Hari Giri, trustee of MVS, several times for the mentioned special project, he avoided giving address. He stated that school is closed due to vacation and school staff is not available. Even local people, near the said project location, were not aware about special school for Orthopaedically Handicapped (OH) in Sirsala. Some of them told that school was there long back. Now it is not functioning.

5. AND WHEREAS it has been established that the conditions incorporated in the Sanction Order have been violated by the NGO and consequential steps as per the following condition is warranted in this case, namely:-


"If the Government is not satisfied with the progress of the project or considers that the conditions of the sanction are being violated, it reserves the right to terminate the grant in aid or to blacklist the organization from future grant or any other financial assistance from the Government."



6. NOW THEREFORE, after considering all the facts of the matter and going into facts of the matter and going into details of the case, it is noted that the NGO has violated the above said condition, which is a serious lapse on the part of the NGO. Accordingly, since the integrity of the NGO namely Manav Vikas Sanstha, at Shelapuri, Post TQ Majalgaon, District-Beed, Maharashtra, Pin- 431331, is doubtful, it is hereby blacklisted for receiving further grant-in-aid from the Government of India for all of its following three projects :-

- I. Special School for Orthopaedically Handicapped (OH), Sirsala. Beed
- II. Special School for Orthopaedically Handicapped (OH), Pathri. Parbhani
- III. Special School for Intellectual Disability (ID), Kalika Nagar. Beed-3-8


