#### CONSTITUTION OF INDIA

No.GH-SH-12-2016-MKM-102006-829-CHH: In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Deputy Director, Class I, in the General State Service, under the Directorate of Social Defence, Gujarat State, namely:

- These rules may be called the Deputy Director, Class I, Recruitment Rules, 2016.
- In these rules, unless the context otherwise requires, "Assistant Director" means the posts included in the annexure, annexed to these rules.
- Appointment to the post of Deputy Director, Class I, in the General State Service, under the Directorate of Social Defence, Gujarat State, shall be made either,-
  - by promotion of a person of proved merit and efficiency from amongst the persons, who,-
  - (i) have worked for not less than eight years in the cadre of Assistant Director, Class II, in the General State Service, under the Directorate of Social Defence Gujarat State; and
  - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having an experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

- (b) by direct selection.
- 4. To be eligible for appointment by direct selection to the post mentioned in rule 3, a candidate shall-
  - (a) not be more than thirty seven years of age :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess a second class Post-Graduate Degree in Social Work obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such by Government or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956.
- (c) (i) have about five years experience on the post not below the rank of Inspector of Certified School, Class III, or equivalent post, in the subordinate service of the Directorate of Social Defence, Gujarat State; or
  - (ii) have about five years experience of social work or sfocial service or social administration in the Government or Local Bodies or Government undertaking Board, or Corporation or Limited Company established under the Companies Act, 2013 on the post which can be considered equivalent to the post not below the rank of Inspector of Certified School, Class III or equivalent post, in the subordinate service of the Directorate of Social Defence, Gujarat State;
- (d) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (e) possess adequate knowledge of Gujarati or Hindi or both.
- A candidate appointed by direct selection shall be on probation for a period of two years.
- A candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-Service Training and Examination Rules, 1970.
- A candidate appointed by direct selection shall during his probation period, be required to
  pass the qualifying examination for computer knowledge in accordance with the provisions
  of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- A candidate appointed by direct selection shall require to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
- A candidate appointed either by direct selection or by promotion shall have to undergo such training and pass such examination as may be prescribed by the Government.
- 10. A candidate appointed by direct selection shall be required to furnish a security and "surety bond in such form, for such amount and for such period as may be prescribed by the Government.
