

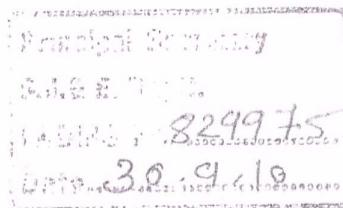

ORDER

The Board will also monitor and review the progress of implementation of the Scheme from time to time.
