## RESOLUTION

Consequent upon the introduction of revised scales of pay under the Gujarat Civil Services (Revision of Pay) Rules, 1998 with effect from 1-1-1996, Government is pleased to decide that in modification of Government Resolution No. ECR-1087-4-M dated 1-6-1987 as amended from time to time, Compensatory Local Allowance and House Rent Allowance to State Government employees shall be admissible at the following rates:-

- 2. The list of cities / towns classified as A-1, A, B-1 and B-2 for the purpose of Compensatory Local Allowance is enclosed at Annexure- I. The list of cities / towns classified as A-1, A, B-1, B-2 and C for the purpose of House Rent Allowance is enclosed at Annexure- II.
- 3. The cities/towns which have been placed in a lower classification in the above mentioned lists, as compared to their existing classification, shall continue to retain in the existing classification until further orders and State Government employees working therein will be entitled to draw the rates of CLA and HRA accordingly.

The employees stationed at Gandhinagar will continue to draw HRA/CLA at the above revised rates applicable to 'A' Class city as per the provision of Government Resolution NO. ECR-1087-99-M dated 28-10-87.

The special order relating to grant of CLA in Jamnagar vide G.R. F. D. No. VLB-1289-GOI-9-J dated 3-4-1989 based on Government of India O.M. No. 11018/6/87/E-II(B) Dt. 29-12-88 shall continue to be applicable.

- 4. Pay for the purpose of these orders, will be pay drawn in the prescribed scale of pay including stagnation increment(s) and non-practising allowance, but shall not include any other type(s) of pay like special pay, or personal pay etc. in the case of those employees who opt to retain the existing scale of pay, it will include, in addition to pay in the pre revised scale, dearness allowance and interim relief appropriate to that pay admissible under orders in existence on 1-1-1996.
- 5. The other conditions at present applicable for grant of HRA in case of sharing of accommodation and other categories shall continue to be applicable.
- 6. These orders shall be effective from 1-8-1997. For the period from 1-1-1996 to 31-7-1997, the above allowances will be drawn at the existing rates on the notional pay in the pre revised scale.
  - 7. These orders shall apply mutatis-mutandis to the following employees also (1) Panchayat employees (2) Teachers in Primary, Secondary, Higher Secondary, Non-Government Schools. (3) Work-charged staff paid from Consolidated Fund of the State Government (4) Non-teaching staff of Universities (5) Employees of Ports Organisation, since transferred to Gujarat Maritime Board, (6) Non-teaching staff of Non-Government Colleges in so far it relates to approved Scale of Pay for approved staff for the purpose of grant in aid.
