

For Appointment of Members in Juvenile Justice Boards(J.J.B.) in 26 Districts of State Under Juvenile Justice Act

Applications are invited from social worker for selection of two members of each district's Juvenile Justice Board, for exercising powers and discharging the functions of the Board in relation to Children in conflict with law under Juvenile Justice (Care and Protection of Children) Act, 2015 in all districts of Gujarat EXCEPT the newly formed 7 districts: Chhota Udepur, Arvalli, Mahisagar, Devbhumi Dwarka, GirSomnath, Morbi, Botad. (One position out of two is reserved for women). The mandatory qualifications required are as under:

1. More than 35 years of age on date: 1.1.2016
 2. Actively involved in health, education, or welfare activities pertaining to children for at least Seven years
- OR
3. A practicing professional with a degree in child psychology, psychiatry, sociology or law

Note:

1. This advertisement is NOT for a Government job.
2. The Members of the Board shall be paid such allowance as prescribed by Government. No other pay or allowances are admissible
3. The person who is appointed as a member of the board shall be appointed for a Maximum period of three years from the date of appointment.
4. If necessary, candidates have to be present before the State Level Selection Committee "for an examination with multiple choice questions (MCQs), computer skills and a personal interview" at one's own costs.

- (9) All persons, on selection shall mandatorily complete the training before being appointed as a member of the Board, failing which the appointment will be cancelled.

The person selected for the post of member of Juvenile Justice Board should not:

- (i) Have been previously convicted in any matter.
- (ii) Have been involved in any immoral act or in an act of violence or exploitation of children;
- (iii) Be holding such full-time occupation that may not allow her/him to give necessary time and attention to the work of the Board as per the Act and the rules;
- (iv) Be associated with any Child Care Institution, directly or indirectly, during his tenure as the member of the Board or have any other conflict of interest;
- (v) Be affiliated to any political party; or
- (vi) Be insolvent
- (vii) Has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
