- 7.0 Grant in Committee has decided to setup sub-committee to review all projects under DDRS through marking for all the received projects. And at that time this 6 projects got less than 20 marks so G.I.A. Committee had not recommended said projects to Government of India.
- 8.0 Out of this 7 Projects, 01 Project <sup>had</sup> got more than 20 marks but ~~do~~ to some error that was not recommended. But all ~~this~~ 7 Projects are ongoing projects hence suggested for year 2015-16 for approval to Government of India.
