MINUTES OF THE MEETING OF SCREENING COMMITTEE FOR SCREENING THE PROPOSALS RECEIVED FOR FOCUSED INTERVENTION PROGRAMMES IN SELECTED DISTRICTS UNDER THE NATIONAL ACTION PLAN FOR DRUG DEMAND REDUCTION (NAPDDR) HELD ON 8<sup>th</sup> AND 9<sup>th</sup> JULY 2019.

A meeting of the Screening Committee constituted by the Ministry of Social Justice and Empowerment was held on 8th and 9th July, 2019 under the Chairpersonship of Smt. Rashmi Chowdhary, Joint Secretary (Social Defence) to scrutinize and make recommendation on the proposals of NGOs/Institutions received through State Governments/Union territories for focused intervention programmes in selected districts under the National Action Plan for Drug Demand Reduction (NAPDDR). List of participants is placed at Annexure-I.

- 2. Smt. Rashmi Chowdhary, Joint Secretary (Social Defence) informed that the Ministry of Social Justice and Empowerment through the National Institute Social Defence (NISD) proposes to undertake Focussed Intervention Programmes in 127 districts across the country under the National Action Plan for Drug Demand Reduction (NAPDDR) by setting up Community Based Peer Led Intervention Centres (CPLIs) and Outreach and Drop in Centres (ODIC). The aim is to reach adolescents and youth in the community and to increase community participation and public cooperation in the reduction of demand for dependence-producing substances and encourage youth dependent on drugs to come forward and seek treatment in safe and secure environment.
- 3. She further informed that the NISD had invited applications from the eligible institutions/NGOs for undertaking focussed/targeted intervention programmes in these districts. The last date for receipt of the application was 15.6.2019. However, NISD had received few proposals of NGOs recommended by the State Government even after 15.6.2019. It was also informed that a total of 672 proposals were received for ODICs and 675 proposals for CPLIs. These proposals included those forwarded directly from the NGOs as well as recommended by the State Governments. Out of total proposals received, 177 were recommended by the State Government for

ODICs and 112 for CPLIs. It was informed that this is the first meeting that has been convened to scrutinize and make recommendation in respect of 23 States as the other states did not forward the proposals of NGOs/ Institutions from their states. It was also decided that direct applications received from the Organizations may not be considered. While scrutinizing the proposals the following parameters were taken into considerations:

- a) All mandatory documents are submitted.
- b) Relevance of the proposal submitted meets the criteria of the district selected/recommended by the Government.
- c) Organization applied has its base and/or is situated in the locality or has the capacity to conduct programme for which it has applied.
- d) Agency applied has got the requisite experience in the sector.
- e) To consider the proposals recommended by the State Government even after the last date in case they are directly operating under the State Government.
- f) Feedback from the State Government representatives were taken into account.
- 4. Representative of Andhra Pradesh Government informed that they had received one proposal of Health Care and Social Welfare Society. They recommend this proposal for consideration of grant stating that the said proposal was received by them before due date but could not be forwarded to NISD by the State Government due to systemic delay. Similar consideration was made by the Government of Rajasthan in case of their one proposal of Nirashrit Mahila Bal Vikash Grammodyog Shiksha Samiti from Jaipur.

- 5. After scrutinizing the proposals, the Committee recommended 61 ODICs 40 CPLIs for receiving Grant under Targeted Intervention Programmes of National Action Plan for Drug Demand Reduction (NAPDDR) as per list placed at Annexure-II. The above recommendations are subject to other conditions and completion of necessary formalities as per the norms/guidelines of the Scheme. It was also decided that in case an Integrated Rehabilitation Centre for Addicts (IRCA) is recommended, it should not be co-located with IRCA premises. The State Governments were requested to forward the proposals for the projects in respect of Registered Societies formed by the State Governments/UT Administrations without waiting for an advertisement. It was suggested that NISD may issue an advertisement in respect of remaining districts where ODIC/CPLI could not be recommended.
- 6. The meeting ended with a vote of thanks to the Chair.
