CONSTITUTION OF INDIA

No.GH-SH-9-2016-MKM-102014-36251 -CHH :-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the posts of Senior Trained Teacher / Junior Trained Teacher / Language Teacher / Montesory Teacher / Literacy Teacher, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State, namely:-

1. These rules may be called the Senior Trained Teacher / Junior Trained Teacher / Language Teacher / Montesory Teacher / Literacy Teacher, Class III, in the Directorate of Social Defence, Recruitment Rules, 2016.
2. Appointment to the posts of Senior Trained Teacher / Junior Trained Teacher / Language Teacher / Montesory Teacher / Literacy Teacher, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State, shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

- (a) not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

- (b)
 - (i) Have passed the Higher Secondary School Certificate from the Secondary and Higher Secondary Education Board; and
 - (ii) have completed two years certificate course of Primary Teacher from any of the Educational Institutions recognised by the Governemnt; and

- (iii) Have passed the Teacher Eligibility Test as may be prescribed by the Government.
- (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 and
- (d) possess adequate knowledge of Gujarati or Hindi or both.
4. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
5. The candidate appointed by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.
6. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
