by the Government of Gujarat under the Central Acts**

### HEALTH AND FAMILY WELFARE DEPARTMENT

#### Notification

Sachivalaya, Gandhinagar, 7<sup>th</sup> February, 2019.

#### Constitution of India.

**No. GP/4/DCA/10/2018/416/JH :-** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Legal Assistant, Class III, in the subordinate service under the Commissionerate of the Food and Drugs Control Administration, Gujarat State, namely :-

1. These rules may be called the Legal Assistant, Class III, Recruitment Rules, 2019.
2. Appointment to the post of Legal Assistant, Class III in the Commissionerate of the Food and Drugs Control Administration shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, the candidate shall, -
  - (a) not be more than 40 years of age:  
Provided that upper age limit may be relaxed in favour of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
  - (b) possess a degree in Law (special) or LL.B. (three years) or degree in Law (integrated) of five years course after passing Higher Secondary School Certificate obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institutions recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;
  - (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (d) have atleast two years of active and continuous experience as advocate in civil or criminal cases in the District Court or on legal side of the Government department, Local authority or a Semi Government Organization; and
- (e) possess adequate knowledge of Gujarati or Hindi or both.
4. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of the candidate appointed by direct selection.
5. The candidate appointed by direct selection shall be required to pass the departmental examination as may be prescribed by the Government.
6. The candidate appointed by direct selection shall be required to undergo such training and pass such examination as may be prescribed by the Government.
7. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
