CONSTITUTION OF INDIA

No. GHM-2019-1-MKM-102013-3163-N :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Deputy Mamlatdar, Class III, in the Subordinate Revenue Services Recruitment Rules, 2010, namely :-

1. These rules may be called the Deputy Mamlatdar, Class III, in the Subordinate Revenue Services Recruitment (Amendment) Rules, 2019.

2. In the Deputy Mamlatdar, Class III, in the Subordinate Revenue Services Recruitment Rules, 2010, in rule 3, after sub-clause (b), the following clause shall be added, namely:-

(c) the appointments by promotion from the Cadre of Clerk or English Typist of Gujarati Typist or Clerk-cum-Typist, Class III Revenue Talati, Class III under clause (a) of sub-rule (A) of rule 2 shall be in the ratio of 1:1.
