CIRCULAR

Different orders have been issued by Government from time to time for grant of travelling allowance, Daily allowance, road Mileage, conveyance charges etc. to non-official members of State level, District level and Taluka level committees appointed by State Government.

2. In absence of consolidated orders regarding entitlement of above allowances, inconvenience has been experienced by the concerned members to make their claims. In order to reduce such inconvenience, the question of issuing the consolidated orders was under consideration of Government. Accordingly, different orders of Government which are relevant, have been summarised in the statement appended to this circular for the sake of general information and guidance.

	In addition to above, Non-Official members are also entitled to Road mileage at the following rates for the journey from Residence to Railway station/Bus station, Air Port and back and journey from railway station/Bus-stop/Air Port to residence or place of meeting at the place of Camp and similarly on the day of departure from the place of meeting.	(1) Full daily allowance is admissible for each completed calendar day of absence reckoned from midnight to midnight. For absence from H.qs. for less than 24 hours, D.A. is admissible at the following rates. (2) Rajkot, Surat, Vadodara (3) Other places	Actual expenditure subject to maximum of Rs. 10 per day.
