No.GH-SH-1-2015-MKM-102014-36248-CHH: In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Probation Officer, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State, namely:-

1. These rules may be called the Probation Officer, Class III, Recruitment Rules, 2016.

2. In these rules, unless the context otherwise requires, Probation Officer, Class III, means the posts included in the Annexure annexed to these

rules.

3. Appointment to the post of Probation Officer, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State shall be made by direct selection.

4. To be eligible for appointment by direct selection to the post mentioned in rule 3, a candidate shall, --

(a) not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of

the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess, -
  - (i) a bachelor's degree in Social Work or Sociology or Psychology as a principal subject obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational Institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;
  - (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
  - (iii) adequate knowledge of Gujarati or Hindi or both.
- 5. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
- 6. The candidate appointed by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government,
- 7. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
