Subject: Modification in the Existing Education Loan Scheme of NSKFDC - Reg.

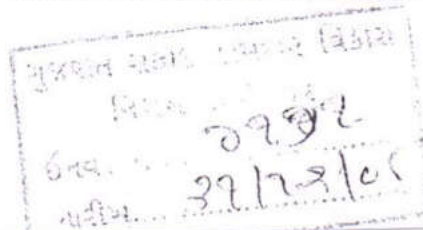
Sir/Madam,

During the 11th Annual General Meeting of NSKFDC for the Financial Year 2007-08 held on 29/09/2008, the Shareholders of NSKFDC i.e. the Secretary & Joint Secretary, Ministry of Social Justice & Empowerment, Government of India (represented by the President of India) had given directions/suggestions for modifications in the existing Education Loan scheme of NSKFDC.

The Education Loan scheme was examined by NSKFDC keeping in view the directions/suggestions of the Shareholders and the same was placed before the Board of Directors of NSKFDC in their 61st Board Meeting held on 12.11.2008. The Board has approved to include the following modifications apart from the existing terms & conditions of Education Loan scheme of NSKFDC: -

1. Apart from the existing component of Education Loan (i.e. Admission fees & Tuition fees, Books, Stationary and other instruments required for the course, examination fee, boarding & lodging expenses and insurance premium for policy), the following items have also been included for the purpose of assessing admissible amount of Education loan: -
 - Travel expenses/passage money for studying abroad.
 - Caution money, Building fund etc;
 - Cost of two wheeler upto Rs.50000/- (on the basis of Performa invoice and the hypothecation of the 2 wheeler in favour of SCA during the currency of loan)
2. Apart from the existing courses being covered under Education Loan scheme of NSKFDC (i.e. any recognized professional or technical education of graduation or higher levels in Medical, Engineering, Management, Law, IT/Computers etc; from authorized institutes/universities), the following courses (of Recognized/Affiliated Universities) have also been included under the Education Loan scheme of NSKFDC: -

- The graduation courses in all disciplines (i.e. B.A., B.Sc; & B.Com etc)
- Diploma in Physiotherapy
- Diploma in Pathology
- Diploma in Nursing
- Diploma in Hotel Management & Tourism
- Diploma in Geriatric Care
- Academic/Professional courses at Graduate & Post Graduate level like Bachelor of Education, Ph.D, Language courses, BCA, MCA, Diploma in Journalism & Mass Communication etc;

In view of the above, it is requested to kindly arrange to send the proposals for sanction of Education Loan under NSKFDC scheme by considering the above modifications under the Education Loan scheme of NSKFDC so that the benefits of Education Loan scheme could be extended to the maximum members of the target group.
